

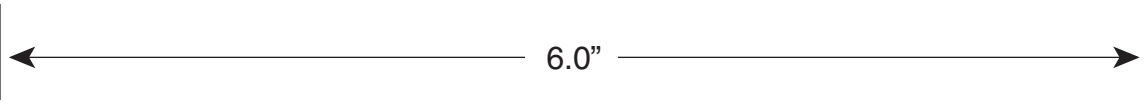

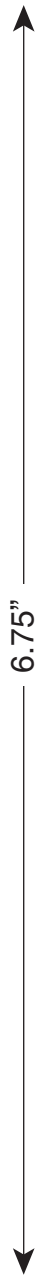

### ENVIRONMENTAL HAZARDS

This pesticide is toxic to mammals, fish and aquatic invertebrates. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. **Container Disposal:** Non-refillable container. Do not reuse or refill this container. Triple rinse or pressure rinse container (or equivalent) promptly after emptying.

Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

Pressure rinse as follows: Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. If necessary, increase the spray volume per acre for complete crop coverage.

**Chemigation:** Do not apply this product through any type of irrigation system.

**Mixing:** Add recommended amount of FOLICUR 3.6 F into the spray tank while filling with water to the desired level. Operate the agitator while mixing. If other materials are added to the spray tank, the FOLICUR 3.6 F should be thoroughly dispersed prior to the addition of other materials.
