DIRECTIONS FOR USE

TURFGRASS: For maintenance of turfgrass, use 6.25 pounds of **WIL-GRO PRO BALANCE 16-16-16** per 1,000 sq. ft. or 275 pounds per acre. For repair of damaged turf (such as divot repair, pet damage, traffic wear, insect or disease damage and/or drought stress) use 6.25 pounds per 1,000 sq. ft. or 275 pounds per acre. For preplant, over-seeding, newly seeded or sod establishment, use 12.5 pounds per 1,000 sq. ft. or 550 pounds per acre.

HYDRO-SEEDING: Add 4 pounds of **WIL-GRO PRO BALANCE 16-16-16** to the hydro-seeding tank per 1,000 sq. ft. of mulch/seed coverage.

GROUNDCOVER, FLOWERBEDS, VEGETABLE GARDENS: Incorporate 20 ounces of **WIL-GRO PRO BALANCE 16-16-16** per 100 sq. ft. or 12.5 pounds per 1,000 sq. ft. into soil before planting. Use 10 ounces per 100 sq. ft. or 6.25 pounds per 1,000 sq. ft. for established or mid-season application. For corn, apply 1 pound per 15 feet of row 3 inches from plant.

SHRUBS AND EVERGREENS: Sprinkle ¼ cup evenly around dripline of plant and work into top 1 inch of soil.

TREES: Apply ½ pound per 1 inch of trunk diameter. Distribute evenly under branches out to dripline.
